RESIDENTIAL RATE - SCHEDULE RS

<b>Customer Charge:</b>	\$14.00 per month
<b>Energy Charge:</b>	.08566 \$ per kWh per month
<b>FCA Charge:</b>	-.00328 \$ per kWh per month

GENERAL POWER RATE - SCHEDULE GSA

(40) 1. Demand is equal to or less than 50 kW (during the latest 12 month period):

<b>Customer Charge:</b>	\$23.00 per delivery point per month
<b>Energy Charge:</b>	.09389 \$ per kWh per month
<b>FCA Charge:</b>	-.00324 \$ per kWh per month

(50) 2. a) Demand is greater than 50 kW but less than or equal to 1,000 kW (during the latest 12 month period):

b) Demand is less than 50 kW and energy is equal to or greater than 15,000 kWh for any month during such period:

<b>Customer Charge:</b>	\$100.00 per delivery point per month

<b>Energy Charge:</b>	.04132\$ per kWh for up to 620 hours use of metered demand per month .03372\$ per kWh for all additional kWh per month
<b>FCA Charge:</b>	-.00318\$ per kWh per month

GENERAL POWER RATE - SCHEDULE GSC

Current effective contract demand is greater than 15,000 kW, but less than or equal to 25,000 kW:

<b>Customer Charge:</b>	\$1,500 per delivery point per month
<b>Demand Charge:</b>	\$15.89 per kW of billing demand per month, plus an additional \$15.89 per kW per month for each kW, of the amount by which the customer's billing demand exceeds its contract demand.
<b>Energy Charge:</b>	.04132\$ per kWh for up to 620 hours use of metered demand per month .03372\$ per kWh for all additional kWh per month
<b>FCA Charge:</b>	-.00318\$ per kWh per month

GENERAL POWER RATE - SCHEDULE GSD

Current effective contract demand is greater than 25,000 kW

<b>Customer Charge:</b>	\$1,500 per delivery point per month
<b>Demand Charge:</b>	\$18.24 per kW of billing demand per month, plus an additional \$18.24 per kW per month for each kW, if any, of the amount by which the customer's billing demand exceeds its contract demand.
<b>Energy Charge:</b>	.03314\$ per kWh per month
<b>FCA Charge:</b>	-.00318\$ per kWh per month

GENERAL POWER RATE - SCHEDULE MSB\*

(Part 1) Current effective contract demand is greater than 5,000 kW and Monthly Metered kW Demand is less than 5,000 kW AND Customers Standard Classification Code (SIC) is between 2000 – 3999 inclusive.

<b>Customer Charge:</b>	\$1,500 per delivery point per month
<b>Demand Charge:</b>	\$14.77 per kW of billing demand per month, plus an additional \$14.77 per kW per month for each kW, of the amount by which the customer's billing demand exceeds its contract demand.
<b>Energy Charge:</b>	.03518\$ per kWh for up to 620 hours use of metered demand per month .02870\$ per kWh for all additional kWh per month
<b>FCA Charge:</b>	-.00318\$ per kWh per month

(Part 2) Current effective contract demand is greater than 5,000 kW and Monthly Metered kW Demand is greater than 5,000 kW but less than or equal to 15,000 kW; AND Customers Standard Classification Code (SIC) is between 2000 – 3999 inclusive.

<b>Customer Charge:</b>	\$1,500 per delivery point per month
<b>Demand Charge:</b>	\$14.09 per kW of billing demand per month, plus an additional \$14.09 per kW per month for each kW, of the amount by which the customer's billing demand exceeds its contract demand.
<b>Energy Charge:</b>	.03341\$ per kWh for up to 620 hours use of metered demand per month .02728\$ per kWh for all additional kWh per month
<b>FCA Charge:</b>	- .00318\$ per kWh per month

GENERAL POWER RATE - SCHEDULE MSC\*

Current effective contract demand is greater than 15,000 kW. but less than or equal to 25,000 kW; AND Customers Standard Classification Code (SIC) is between 2000 – 3999 inclusive.

<b>Customer Charge:</b>	\$1,500 per delivery point per month
<b>Demand Charge:</b>	\$13.58 per kW of billing demand per month, plus an additional \$13.58 per kW per month for each kW, of the amount by which the customer's billing demand exceeds its contract demand.
<b>Energy Charge:</b>	.03341\$ per kWh for up to 620 hours use of metered demand per month .02728\$ per kWh for all additional kWh per month
<b>FCA Charge:</b>	-.00318\$ per kWh per month

GENERAL POWER RATE - SCHEDULE MSD\*

Current effective contract demand is greater than 25,000 kW

AND Customers Standard Classification Code (SIC) is between 2000 – 3999 inclusive.

**Customer Charge:** \$1,500 per delivery point per month

**Demand Charge:** \$14.78 per kW of billing demand per month, plus an additional \$14.78 per kW per month for each kW, if any, of the amount by which the customer's billing demand exceeds its contract demand.

**Energy Charge:** .02679 \$ per kWh per month

**FCA Charge:** -.00318 \$ per kWh per month

Parts A and B:

**Energy Charge:** .05888 \$ per kWh per month

**FCA Charge:** -.00328 \$ per kWh per month
